Financial aid refunds will not be processed until the student is awarded and the student is enrolled. Once awarded, students will receive an invitation message via their Message Center to sign up for Direct Deposit (which will require an active bank account), Prepaid Debit Card. If a refund option is not selected a paper check will be mailed to the student using the address on file. Check your My.Maricopa.edu (Student Service Center) account often for important messages from Money Network on how to enroll and pick refund options.

Students who are awarded a Pell Grant prior to the scheduled Pell Census Date cannot have their Pell Grant award increased after the census date for that term. This applies to adding classes at SMCC and/or turning in Consortium Agreements for courses taken at other colleges. In order to be eligible for a Pell Grant for all classes, the student must be registered by the census date (this applies to late start classes as well) and if applicable, the Financial Aid Office must have a completed consortium agreement by the census date.

Students who apply and are awarded a Pell Grant after the census date will have their Pell Grant award based on the number of credit hours they are enrolled in on the day their Pell Grant award is posted to their account.
